LIMITED REVIEW REPORT

We have reviewed the accompanying statement of Unaudited Financial Results of **Axel Polymers Limited** for the Quarter & Nine Months ended December 31st, 2025. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our review of the statement in accordance with the Standard on Review Engagement (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with applicable Indian Accounting Standard (Ind AS), as prescribed under section 133 of the Companies Act, 2013 read with relevant Rules and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016/ dated July 5, 2016, including the manner in which it is to be disclosed, or that it contains any material misstatement.

It is to further state that the Goods and Service Tax Authorities had carried out search proceedings at factory premises of the Company on 03.07.2024.

The Office of the Commissioner, Central GST & Central Excise, Vadodara II, has issued Show Cause Notice to Axel Polymers Limited. The matter pertains to alleged availment and passing of Input Tax Credit (ITC) by issuance / receipt of invoices without actual movement of goods during FY 2021-22 to FY 2024-25. The Notice proposes reversal of ITC amounting to approximately ₹31.57 crore, along with recovery of interest and penalty.
